Personal Data Protection

On the 25th of May 2018, the European Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data ("the Regulation") became effective. Data Processing

The personal data (the data of parents/ guardians: surname, first name, address, email, telephone; the data of children: surname, first name, date of birth, gender, size, medical history) are processed for the good development of the Summer Camp schedule, as well for the communication with the parents (notification of the schedule, menu, etc.), by virtue of and for the purposes of fulfilling the contractual relation set forth for the performance of the services that you requested. In the absence of such data, we cannot fulfil our obligations for the performance of the requested services. We will preserve your data as long as the contractual relation for the performance of the services is valid plus a 5-year period. If after such period, the data whose preservation is required or allowed by law (invoices, documents issued by a commercial company) will be archived safely for a 10-year period, as for the invoices, respectively a 30-year period, as for the documents issued by a commercial company.

- ✓ the right to rectification of the inaccurate or non-updated data
- ✓ the right to erasure of the personal data, under the conditions and in the cases provided for by law
- ✓ the right to restriction of the processing, under the conditions and in the cases provided for by law
- ✓ the right not be subject to a decision based on the automated data processing
- ✓ the right to your personal data portability (insofar as your data have been processed by automated means and the portability is possible).
- ✓ when your personal data are processed for direct marketing purposes, you have the right to object at any time to processing of data for such purpose, including profiling to the extent that it is related to such direct marketing and we will no longer process the data concerning you for such purpose.
- ✓ the right to object to processing of the personal data concerning you which is based on the public interest or legitimate interest, in certain cases and under the conditions provided for by law.
- ✓ for the cases for which we rely on your consent for processing, you have the right to withdraw consent at any time for the processing of data.
